Building for the Future of Nebraska's Agricultural Cooperatives

The Nebraska Cooperative Council Education Foundation has been established by the Nebraska Cooperative Council for the purpose of enhancing the educational offerings to the cooperative and agribusiness industry. Education has always been one of the core values of the cooperative movement in Nebraska.

S pecific allowable uses of Foundation funds are:

- Scholarship programs for high school graduates to continue their education at Nebraska post-secondary institutions that provide agribusiness management programs.
- Continuing education programs for local cooperative directors and employees.
- Youth education programs for projects such as curriculum development or co-op day camps.
- Travel/study scholarships for cooperative employees to attend programs such as the Graduate Institute of Cooperative Leadership or educational events of the National Council of Farmer Cooperatives.
- Intern scholarships to allow students to explore cooperative career opportunities and conduct research projects for cooperatives.
- Special educational projects that would enhance the cooperative movement in the state. An example would be the Cooperative Recruitment Project that we conducted or the Director Certification Program video update project.



2009/10 FOUNDATION HIGHLIGHTS

- The Foundation continues to increase the endowment fund for the Scholarship Program in Honor of Michael S. Turner.
- To date we have received contributions of \$205,831.38 and grants totaling \$85,637.74.
- In the fall of 2009, the Foundation distributed a 12-minute video entitled *Cooperatives 101* to all ag teachers and Nebraska cooperatives. This video, requested by teachers, was produced by the Council to explain cooperatives. It will also serve as a useful tool for local cooperatives during new employee orientation. This video, made possible thru a CHS Foundation grant, was the final step in the youth curriculum upgrade.

SCHOLARSHIP PROGRAM

The Nebraska Cooperative
Council Education Foundation
awarded 7 scholarships totaling
\$6,050 for the 2010/11
academic year to students at
the University of Nebraska Lincoln (UNL) College of
Agricultural Sciences & Natural
Resources, the Nebraska
College of Technical Agriculture
(NCTA) at Curtis, and Chadron
State College (CSC).

The scholarship program was initiated in the 1993/94 academic year with voluntary contribution funding from cooperatives which are members of the Council. Since the program's inception, 137 scholarships totaling \$103,650 have been awarded.

To be eligible for the scholarships, students must be majoring in agricultural business/economics at UNL: business/management or ag production systems with the business option at NCTA; or a major or minor in agribusiness at CSC. Eligibility is restricted to sons or daughters of a parent or legal quardian who has been an active member. director, or employee for at least the prior three years of a cooperative which has been a member in good standing of the Council for at least five years. Other criteria are used by UNL, NCTA, and CSC in selecting recipients.

Scholarship Recipients for the 2010/11 Academic Year

The five recipients of \$950 scholarships at UNL include one incoming student and four upperclass students. They are:
